Effective January 1, 2018

### **EXPRESS SERVICE & ENHANCEMENTS:**

- High frequency service all day (15 -20 minutes) - Lower frequencies during late night/ early morning hours
- Limited stops (approximately every 1-2 miles)
- Operates weekdays, nights and weekends
- Approximate span of service 5:00 AM to 1:00 AM
- Improved access to DDOT routes
- Onboard WiFi
- Simplified Corridor Service

#### **ROUTE CHANGES:**


- 445 Maple & Telegraph Limited REINSTATED as currently operated
