

## Reduced Fare ID Application

The Senior and Youth Reduced Fare ID Cards are accepted on SMART and DDOT Fixed Route buses. Detroit residents must apply through the mail to: DDOT Administration, 1301 E. Warren, Detroit, MI 48207.

### Application Instructions

**1. Include the following information:**

- a) Completed Reduced Fare ID Application with \$1.00 fee - cash or money order payable to SMART
- b) **ID Requirements:**  
 Senior: Copy of applicant's State of Michigan driver license or ID or other picture identification verifying date of birth  
*(Originals will not be returned)*  
 Youth: Copy of applicant's birth certificate verifying date of birth  
*(Original will not be returned)*
- c) Head and shoulder color photo of applicant. Photo must fit in the box to the right. **A color copy of applicant's State of Michigan driver license or ID is acceptable.**



- d) Self-Addressed Stamped Business-Size Envelope

**Replacement Cards**

Reduced Fare ID cards may be replaced for a fee. Payment must be made with a money order **ONLY**. A \$5.00 fee will be applied for the first replacement card. An additional \$5.00 fee will be applied (i.e. \$10.00, \$15.00, \$20.00, etc.) for replacements thereafter.

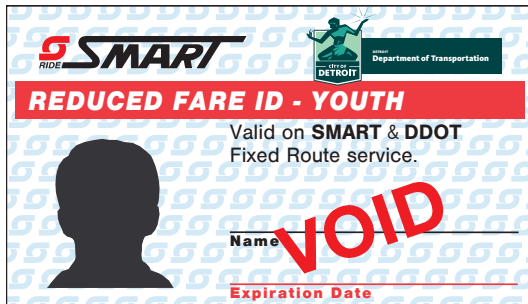
The Disabled Reduced Fare ID Card entitles seniors (65+) and youths (6-18 years) a 50¢ one-way reduced fare on SMART & DDOT Fixed Route buses and seniors (65+) a \$1.00 one-way fare for SMART Connector general service.

## Eligibility and Requirements

The Reduced Fare ID Card is a convenient and quick way to receive the reduced fare. Other forms of identification to verify age may be used in place of the Reduced Fare ID Card (see below). Simply fill out the application on the back of this form and send in the appropriate documentation for verification purposes.

### Youth ID Card - 6 to 18 years old

Entitles youths to a 50¢ one-way reduced fare on SMART and DDOT Fixed Route buses.

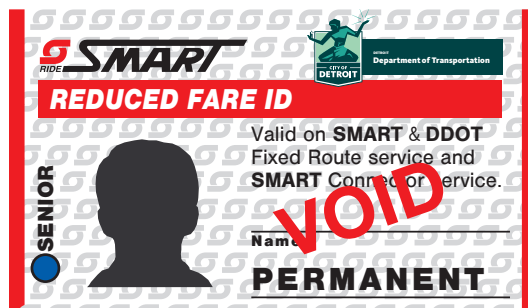


The following may also be used to verify age when boarding SMART:

- School ID that includes photograph and current school year
- State of Michigan ID
- State of Michigan Driver License

### Senior ID Card - Adults 65 years and older

Entitles adults age 65+ a 50¢ one-way reduced fare on SMART and DDOT Fixed Route buses and a \$1.00 one-way fare for SMART Connector general service.



The following may also be used when boarding SMART to verify age:

- State of Michigan Driver license
- State of Michigan ID
- Medicare Card with picture ID

1. An incomplete application will not be processed.
2. **Submission of all required documents does not guarantee approval for the Reduced Fare Program.**
3. Please allow 5-10 days for application processing.
4. Reduced Fare ID cards may be replaced for a fee. Payment must be made with a money order **ONLY**. A \$5.00 fee will be applied for the first replacement card. For replacements thereafter, an additional \$5.00 fee will be applied (i.e. \$10.00, \$15.00, \$20.00, etc.) The Renewal Card fee is \$1.00.
